

VOTING RESULTS OF THE ANNUAL GENERAL MEETING OF SHAREHOLDERS OF FERRARI N.V. HELD ON WEDNESDAY APRIL 17, 2024

As of March 20, 2024 – the record date for the Annual General Meeting of Shareholders (the **"AGM"**) of Ferrari N.V. (the **"Company"**) – the Company's outstanding share capital amounted to 180,162,331 common shares and 63,332,872 special voting shares, each share having a nominal value of one eurocent. These amounts exclude 13,761,168 common shares and 16,240 special voting shares held by the Company. Each outstanding share carries one vote. In total, 243,495,203 votes could be validly cast.

At the AGM 141,216,335 common shares, constituting 78.38% of all outstanding common shares, and 63,328,351 special voting shares, constituting 99.99% of all outstanding special voting shares, in the capital of the Company as of the record date were present or represented at the meeting. In total, 84.00% of all outstanding shares (common and special) in the capital of the Company were present or represented at the meeting. The total number of voting rights present or represented at the meeting amounted to 204,544,686.
